

“Late last year, James Walbert went to court, to stop his former business associate from blasting him with mind-altering electromagnetic radiation. Walbert told the Sedgwick County, Kansas panel that Jeremiah Redford threatened him with “jolts of radiation” after a disagreement over a business deal. Later, Walbert, said, he began feeling electric shock sensations, hearing electronically generated tones, and getting popping and ringing sounds in his ears. On December 30th, the court decided in Walbert’s favor, and issued a first-of-its-kind order of protection, banning Redford from using “electronic means” to further harass Walbert. No, seriously.

I recently took part in a BBC Radio 4 program, which took a light-hearted look into the “the real Manchurian Candidate” — and examined whether there is any truth in stories of mind control. It gave me a chance to talk about exotic non-lethal weapon concepts like the so-called telepathic raygun, the system which beams sound directly into your skull, and the “voice of god” talking fireball. Most of these projects are just lab experiments, or examples of Powerpoint engineering. But in some legal, policy, and business circles, electromagnetic brain assaults are being taken seriously.

Walbert’s cause is supported by Jim Guest, a Republican member of the Missouri House of Representatives. He’s working on proposed legislation to addresses electronic harassment, including a bill against the forced implantation of RFID chips.

The U.N. is also now taking the possibility of electromagnetic terrorism against people seriously. And for the first time this year's European Symposium on Non-lethal Weapons included a session on the social implications of non-lethal weapons, with specific reference to "privacy-invasive remote interrogation and behavioral influence applications." Those who believe they are being targeted are getting a bit of official recognition.

For some, this opens up a new business opportunity. There are already quite a few companies out there offering "Technical Surveillance Counter Measures," or sweeps to determine if you are the victim of electronic harassment. As well detecting the usual bugging devices, they can check if you are being covertly bombarded by microwaves which may be the cause of "headache, eye irritation, dizziness, nausea, skin rash, facial swelling, weakness, fatigue, pain in joints and/or muscles, buzzing/ringing in ears."

Much of this trade may come from people with symptoms caused by something less exotic than high-tech military hardware. But companies will no doubt be willing to sell them expensive protection measures, anyway. And as awareness of these developing technology projects increases, we are likely to be hearing a lot more about "electronic harassment," "gang stalking" and the like over the next few years.

And there is also likely to be what folklorists call "Ostension," or acting out. Now that there are so many websites explaining how easy it is to harass people by zapping them with a modified microwave oven, sooner or later someone is bound to try it."

Introduction

Numerous surveillance programs are performed on unsuspecting citizens. Although Americans knew that the NSA was spying on their phone calls, emails, and even some private homes – the Edward Snowden fiasco brought to our attention the vast reality of the NSA's spying program.

Did we need an official government document to prove what we already knew? Is reality only acceptable with a government document?

Years prior to the NSA “whistleblower” Edward Snowden, which released thousands of classified documents to the media, the NSA's “PRISM” program was listed in the Encyclopedia. In reality, the entire program was exposed before Edward Snowden stepped into the spotlight. Edward Snowden merely released documents that obtained proof of specific individuals and abuses that were used by the NSA's surveillance team.

A person becomes a “whistleblower” if they are a government employee, and speak out against wrongdoing within the government. A person becomes a “targeted individual” for much the same reason, but is not employed by the government.

Many federal laws exist to protect whistleblowers. For targeted individuals, otherwise known as “TIs” with a self-created label of injustice, mercy begins and ends with self-defense and local law enforcement agencies.

Becoming a targeted individual of our government is kept in secret. If you were to speak out against the government in countries such as North Korea, you would be tortured and/or killed in public. In America, this is done in secret.

There is no record of any nation that has not historically been involved in the targeting of its own citizens for exposing corruption. Every single government that has ever existed has multiple counts of human rights violations against activists.

Technological advances have allowed our government to torture citizens, silently (1).

COINTELPRO and Project Monarch: Disinformation Campaigns Against Whistleblowers

COINTELPRO was a program that was originally designed to silence government dissidents, end progressive anti-racism campaigns, and create paranoia and confusion between peaceful parties.

The KKK was infiltrated. The Black Panthers were infiltrated. If we ever wonder “who fired the first shot,” there is no need to at this point. Agent Provocateurs, violence inciters, drama queens – are all around us.

Thousands of agents are employed by the FBI's Special Surveillance Group, the Joint Terrorism Task Force, and other extremely corrupt divisions in order to create the need for “national security.” What I cannot begin to explain with words is known by every employee.

What I cannot understand for myself is performed by these agents on a daily basis. The FBI's SSG and JTTF's sole purpose is to create the need for security. How can you create a need for security? Would she be arrested for felony stalking? How many recruited “men” could she trick into harassing the TI by the end of the day?

With a smile and a slight wink – she could take over the block. The neighbors would hate the TI, the TI would only be left with two questions: “how and why?”

Now, we know how easy that it would be to destroy someone's life. By creating a supposed threat, by “men” wanting to please any woman without question, based on their own lustful desires for a woman that doesn't give two shits about him (and thinks that he's a total douchebag for even thinking of participating in something so obviously stupid and deceptive), the “conspiracy” begins.

The “Occupy Protests” were labeled as a “possible terrorist threat” by the FBI's Joint Terrorism Task force.

The media is the fourth branch of the government. Do not trust the media for your only source of information. Over half of the “terrorist plots” and “school shootings” were either performed by FBI informants (paid) or completely faked. Do yourself a favor, and do not believe whatever you see on TV. As with all channels, it's usually nothing more than a pathetic show that isn't worth watching.

Due Process and organized stalking. Where do we start with that subject? Due process is the only thing that separates the sophisticated from the classless. When illegal surveillance begins on a person, so does violence incitement. Never, ever believe anything that you hear about a person that claims targeting. Unfortunately, that person is a victim of control and filming. Nothing more, nothing less.

I also want to provide specific court cases that relate to forced implantation of RFID chips, as well as a court case regarding electronic harassment.

I do understand that some find this subject difficult to understand, and therefore, hard to believe. So, I will provide a “clear cut” court case for each instance – based on factual evidence that has been presented before a judge in a court of law: James Walberg. Please research the case and the transcript for more information. The original article, courtesy of Wired News, is provided in the first few pages of this book.

When COINTELPRO began in the 1960s, it was known as the original form of “gang stalking.” This type of program was not new to the American Government, however. This is when it began to use it against its own citizens.

In the early 1950s, the CIA paid a group of “thugs and prostitutes” to destroy a government. That government was about to be replaced by a democracy, rather than the current dictatorship. The CIA paid random people to fight against and harass the opposing forces, eventually sparking riots that convinced the government to remain a dictatorship (2).

Organized stalking proved to be an effective measure in this situation, especially considering that most of these “thugs and prostitutes” were also drug users – and therefore, would do anything for their next “fix.”

Project Monarch is the supposed “new name” for COINTELPRO. Project Monarch uses various surveillance methods to harass Targeted Individuals.


TIs experience 24/7 harassment, in an attempt to bring about one of the following:

- 1) *Suicide*
- 2) *A mental diagnosis (disinformation)*
- 3) *Homelessness / “Make them 'disappear'”*

Dr. Martin Luther King, one of the greatest (and most outspoken) men to ever walk the earth, was a COINTELPRO target for numerous years.

The FBI has been convicted in court of killing MLK Jr., but only in a civil case – similar to the murder of Nicole Simpson by OJ.

The easiest method to silence a dissenter, without drawing a guilty conscious (even for a sociopath without conscious who is afraid of prosecution), is the suicide of the target.



It's obvious to everyone what happened – but it seems that justice just isn't served in some cases. With federal agencies – it is never served. After all, who prosecutes themselves for crimes committed?

Disinformation, repression, and silence are the keyword here. When a whistleblower becomes a target, the ultimate goal is to create the illusion that this person is “insane.”

I'll mention more about the suicide goal in the last chapter with Ernest Hemingway, who was driven insane by FBI surveillance. Before Ernest Hemingway committed suicide, and even ten years after his death, many people believed that he was insane. In fact, his own family believed that he was “delusional.”

After the FBI surveillance records were released, following Ernest Hemingway's suicide, it was a decade too late to believe what the writer was saying. One decade too late, one life cut too short.

Why? Was he a threat? A communist? No. He was Fidel Castro's "friend," which was otherwise known as someone whom he took a few photos with.

Cathy O'Brien is a very notable Project Monarch "participant" (victim). Cathy O'Brien stated that she had received constant harassment, surveillance, and other forms of "invisible" (electronic) torture.

Former FBI Chief Ted Gunderson also stated the same, after he had begun to perform speeches about various forms of corruption within the FBI.

Enough examples. Let's explore some "no-name" Tis. The "unimportant" ones who are buried by dozens of hired felony stalkers.

Most of the programs that whistleblowers expose are related to government corruption that ultimately results in the death of multiple individuals. Such examples are "false-flag" war operations, cloud seeding experiments, and illegal government tests.

Tis are not "tattletales," or anarchists. Tis, in most circumstances, are peace activists and inventors. The more outspoken that a TI is, the more creative that they become, the less of a slave that they are. We must first realize that we are a slave before we know that we have to become free.

The government has a multitude of individuals to make sure that this never happens. Progression is change, and change threatens stability. Not the stability of the country, the economy, or national security. Change threatens their job. Peace threatens war. War cessation threatens their paycheck.

I know how governments work. I dated a Department of Defense secretary who "inflates the budget on purpose" to "increase the Department of Defense's funding." I knew another person who was contracted for the Department of Defense, who gave me the same exact answer.

"They said, 'we can increase the budget next year, but we have to spend such-and-such amount this year. Find how much that we have to spend, make it fit into someone's paycheck, and get us the increase.' And I paid a guy \$40 per hour to enter Excel spreadsheets. It's normally \$10 per hour work."

For some reason, I wasn't surprised when I heard this. I'm sure that none of us are. We all know what really goes on, but denial sometimes gets the best of us. Truth is extremely difficult to fathom; simply because it is stranger than fiction.

Instances such as these, when the government is threatened to answer for what they do or risks losing a taxpayer-funded paycheck, a retaliation is applied.

As a Ponsi scheme artist runs from the truth while embezzling more people's money along the way, the Ponsi scheme artist must feel that he is in control of the situation at all times.

Much as a man beats his wife and mentally abuses her to feel – how shall I say – just bad enough to keep from leaving him. If the woman thinks that she doesn't deserve better, just like the control-freak tells her, she won't leave him to see that she does deserve better. Much, much better. At the time, she just doesn't know it. Like a taskmaster whips a slave into submission, a TI is beaten into the dust from which they came.

If a whistleblower or TI is simply killed, the disinformation campaign does not work as well (obviously).

After all, everyone has perception. Wouldn't the general public eventually “figure it out” if every whistleblower or targeted individual started dying from “natural causes?”

Disinformation campaigns are the ultimate choice for any government “security” agency. Targeting the individual's sense of reality is the only way to disprove what has been done by the government. After all, can the TI prove what he or she says? More than likely, yes. However, who would believe that such a huge conspiracy exists against an “unimportant” person?

In the eyes of a stalker, the unimportant person is nothing more than a dog to beat. The child that stands over the animal, feeling powerful because the animal is under their control. Abusers love power. What they love more is money – and for performing felony stalking under the umbrella of “national security” - what more could a creep ask for?

The government is guilty of a huge crime, which is punishable by life imprisonment (most whistleblower-exposed crimes involve acts of treason). The only thing left to do, is to make the general public think that this individual is nuts, so that they do not believe what is being said by that individual.

This is the equivalent of the Nazis versus the Jews in the 1940s. The Nazis always spread lies and rumors, stating that “Jews were the problem in society.”

In those days, Jews were the doctors, the lawyers – the white-collared geniuses. Not anymore, under Hitler's watch.

So now that we know these programs actually exist, and have for quite some time, we will explore what happens to these “whistleblowers,” and TIs that decide to expose illegal and immoral programs within our government.

Organized “Gang” Stalking and Electronic Harassment

Although electronic weapons (also known as “directed energy weapons”) have been around for quite some time, most of the general public is still oblivious to their existence.

Directed energy weapons are a rather simple method of harassment, and are only illegal in one state currently – which is Michigan (*Act No. 256. Public Acts of 2003*).

“Gang stalkers” use directed energy weapons, some as simple as a cell phone, to torture and manipulate whistleblowers into a state of silence. There is also significant circumstantial evidence that “Gwen towers” are used to target specific individuals, and that topic is covered in great detail within Jesse Ventura's Tru-TV Network “Conspiracy Theory” episode “Brain Invaders.”

Methods of intimidation intend to silence government dissidents through remote control – which furthers the anger of the targeted individual – as he or she is unable to defend themselves against electronic weapons.

Noise campaigns against the individual are incessant. Whether it is by “Voice of God” technology or by actual neighborhood disruption (i.e. horn honking, loud after-market mufflers, personal harassment via “sniffing” or other annoyances), the noise campaign is almost immediately implemented as a first goal for the affected.

As with Pavlov experiments performed with dogs and other animals: the target can be placed under surveillance and “measured” to see their reaction to each individual sound. From that point on, it is used as an incitement and attention-seeking technique. The goal of stalking is to keep the focus on the stalkers. The objective for the affected is to “not feed the trolls.” Feeding a troll is like feeding a stray dog. They will only come around for more food.

The individual feels helpless, and relies on police to stop what everyone seems to know is going on.

If the individual reacts to the stalking and harassment with physical violence, the TI will be the one who appears to be the problem in society.

This is exactly the goal and the point of electronic harassment.

Methods that are used against targeted individuals include:

- 1) ***“Voice of God weapons”***
- 2) ***Active Denial Systems***
- 3) ***Mind Control via RFID***
- 4) ***Constant Stalking***
- 5) ***Aerosol Targeting***

“Voice of God” weapons are otherwise known as “Directed Radio Frequency” signals.

Directed radio frequencies can penetrate the individual's mind, causing them to hear voices or sounds that nobody else can hear. Unlike a mental illness, this is not a hallucination.

The human brain operates on a certain frequency, and with the simple knowledge of that frequency, the human mind can be easily manipulated.

In the case of Patent 5159703, the frequency is directed into the individual's skull through radio frequencies, similar to a radio receiving a music or voice transmission. In this instance, however, only the person that is meant to receive the transmission will hear the “radio” transmission. This is done rather simply and easily – yet the “intelligence” agents think that it is somehow ingenious.

By funneling an antenna into a laser-directed beam, only the receiving point will hear the radio frequency. Very simple. Two men with two tin cans and a string, yet one man is not holding the other end – and the “man” at the other end of the tin can is actually one of the lowest forms of life that you could ever imagine... a stalker.

A great video to watch on this subject is Jesse Ventura's Conspiracy Theory Episode, “Brain Invaders.” This episode completely describes the torture that these individuals go through on a daily basis due to VOG weapons.

Active Denial Systems are easily obtainable, and are a prime weapon in “gang stalking.” ADS uses an ultra-high microwave frequency to “cook” the individual's flesh, penetrating a few millimeters through the skin – creating a very uncomfortable heat sensation that tends to annoy the targeted individual. With the use of a simple light or invisible radio-emission tool, the target is able to be harassed – especially during their sleep.

Mind control is a rather easy subject to touch on, although most people don't even know that such a technology even exists.

Mind control has been researched by the CIA since the 1950s, and the research has allowed mind control to be performed wirelessly – without the individual's knowledge.

Unlike MK-Ultra, the victim has no idea that they are under mind control. This is much similar to hypnosis – causing the person to do something without their consent or freewill to choose. With RFID technology, mind-control has become one of the simplest tactics to implement on a TI. Although the individual may or may not remember the experience that took place under mind control, the individual knows that it wasn't themselves that performed those actions.

Government “patsies” are excellent examples of this; who have long been used to fulfill government assassinations and other extreme plots of terror.

One minute, the guy is shooting someone. The next, he is reading “Catcher in the Rye,” waiting on police to escort him to his prison cell.

May I also make a note of interest about John Lennon's assassination... John Lennon, and his wife Yoko Ono, were both targets of COINTELPRO.

President Hoover wanted to have both individuals “deported” - especially after producing the hit song “Give Peace a Chance.” Shortly afterwards, a huge nationwide anti-Beatles campaign began, and hundreds of people burned their Beatles memorabilia.

Need I say more?

Back to RFID. RFID implementation and individualization is rather easy, actually. All that is required is one person, one 0.4mm RFID chip, and a parked vehicle. In more sophisticated instances, large tracking devices are covertly installed on vehicles, usually under the hood or wheel wells [4].

The unsuspecting TI will exit from the store on their daily routine, and feel a small sting – usually in their back. Using various “injection methods” from a distance, the target will go to work, school, home, or anywhere outside – the target can become easily “chipped” without their knowledge.

Blow darts were used during the era of Japanese ninjas, and are even featured in popular video games such as “Assassin's Creed.”

For assassination techniques, a closer technique is used. For anti-fluff purposes in my writings, I will not detail into this subject – but further readings and videos are available online by searching the term “umbrella assassin.”

RFID, short for “Radio Frequency Identification,” is a very sophisticated, yet so simple, method of torture and harassment.

Unfortunately, RFID materials have been consumed by every living being on the planet. RFID ink, RFID chips, and RFID tags are all around us – all day long.

How does Wal-Mart know when a thief snatches a CD player? The RFID tag. How does the mechanic know that you haven't had a tune-up in a year? The RFID tag. How can you tap your credit card against a reader and give your information to a sensor? An RFID tag.

Everything is “tagged,” and so is “everyone.” Further information will be explained in the “aerosol targeting” portion of this writing.

Each RFID chip is programmed to a specific number, a specific frequency. These same RFID chips are now used to track pets and children via satellite.

Passive RFID chips (non-self powered) gain operation through passing wireless Internet waves, cell phone towers, and other wireless electronic equipment. Losing a signal on RFID ink or an RFID chip is nearly impossible with the Verizon “can you hear me now” coverage map.

“Winston says that Oceania’s world of telescreens and Thought Police means that there are 'always the eyes watching you and the voice enveloping you. Asleep or awake, working or eating, indoors or out of doors, in the bath or in bed—no escape.’”

Although I make many references to the 1984 George Orwell film, I must reiterate the cult following of the once science-fiction classic. There are people who want this for society. There are control freaks. There are millions of sociopaths. There are serial killers free, roaming the streets, as we speak.

Surveillance has not stopped any of them. Nothing, nada, zip – zilch.

I am not against surveillance in public. I believe that if a person chooses to enter downtown Las Vegas, on the strip, and gets shot by someone else – as has happened multiple times – we need some proof in court as to who performed the shooting. Who would not agree? Why would a camera not be pointed at a location that is known for violence?

Once a man steps foot inside of his home, once a man pulls into his parking lot, what he does inside of his home is strictly his business. When a man calls his wife to ask what she would like for dinner, the NSA has no business knowing about their chicken soup while “preventing terrorism.”

This is rather obvious for most of us.

I do believe that some good people exist within the NSA, FBI, and CIA. I believe that they are also kept quiet, just as Tis are kept quiet.

People who know too much also know that if they speak too much – they will be silenced.

One of the main goals of the disinformation campaign via stalking and harassment, as stated, is to silence the individual. Cause a provocation. Violence. Create a hermit, a recluse, a “paranoid.”

Stalking will cause an individual to become violent, aggressive, and withdrawn. The targeted individual that experiences stalking, like anyone else who has experienced the worst crime known to date, will wish for retaliation against their perpetrators. However, they continue to experience the same stalking, day after day.

Stalking is the equivalent of rape. When a man rapes a woman, he forces himself into her personal space. Her protected, personal, private space.

People who stalk people and rape people, unfortunately, have no hope in life. They have committed, in my mind, an unforgivable crime.

I would take a bullet for any of my fellow men. I would watch a rapist die in the electric chair without personal conviction. I have no sympathy for the only crime against God-given freewill – which is stealing someone else's freewill of choice from them.

Of course the self-defense method is out against stalkers. How can you defend against someone who stalks you on a public street?

The individual may contact the police, may ask family or friends for help – only to portray themselves as a delusional “victim.” When a targeted individual tells police that they have multiple stalkers, and explains that they are stalked by an organization such as the CIA, FBI, or NSA - the individual is automatically labeled as insane. That is, unless the police officer knows the true history of these organizations.

The reality of the CIA, the FBI, the NSA is not very difficult to grasp. All of these organizations claim to “watch” individuals. All three organizations are spy organizations, and to ever think that these individuals are nothing more than stalkers with badges – would be rather

ignorant. However, some people in society actually believe that these organizations are “important.” They “protect us from terrorism.” The irony of that statement could never be more entertaining.

Aerosol targeting can be used to improve the disinformation campaign, and rather quickly. Within geoengineering, aerosol particles are released with a positive charge (i.e. NASA's “CARE” program, short for Charged Aerosol Release Experiment).

Example materials include:

- 1) Manganese Sulfate**
- 2) Iron Sulfate**
- 3) Barium Sulfate**
- 4) Gram-negative Soil Bacteria – i.e. Morgellons (Wikipedia, Bioprecipitation)**
- 5) Aluminum**

These materials can cause the individual to seem autistic, dyslexic, disorientated, and over-emotional.

Targeting the individual is rather easy, actually, because all that someone would have to do is create a negative charge within the individual's home. In physics, we all know that “opposites attract.” Electricity must flow from a positive to a negative pole in order to produce a flow. Otherwise, it is a dead charge.

Directed negative ion generators can be pointed at the target's window, which “attracts” the positive particles. Raytheon has created multiple weapons that are now used against American citizens, such as Radio Frequency emission devices – which are used to target homes and individuals within the homes.

While the individual smells sulfur and aluminum, their neighbors seem to be fine. Actually, the neighbors seem to think that the targeted individual is “going crazy.” An overload of these particles can cause severe problems for the targeted individual; emotionally, mentally, and physically.

Although everyone (obviously) is affected by the aerosol releases, the individual who is targeted will seem the most affected. It is similar to dumbing down the Nazis with meth, while fluoridating the Jews' water supply to keep them complacent. Both the Nazis and the Jews, in this case, are made to be “mindless drones.”

If an individual is excessively outspoken, he or she can be targeted by individual aircraft.

The aircraft, usually using bogus names and missions such as “JIA” Cessna aircraft or passenger-less American Eagle aircraft, can be used to “distribute” materials over the target's home. Evergreen Aviation, located at Pinal Air Park in Marana, Arizona, is a CIA base that is used to store hundreds of passenger aircraft – that are not used to transport passengers. Once labeled a “bone-yard,” which is nothing more than a present-day aircraft chop shop.

This is the easiest way to cause a target to appear insane. After all, who would believe them – if they tried to tell someone that the “CIA was attacking them with planes?” Although the

aircraft has no purpose in the sky, although they are emitting visible chemicals from their bow (and are even registered to Pinal Air Park in some cases), who would believe that these planes are actually committing acts of treason on American citizens?

Most people would rather believe whatever Glenn Beck says, to be honest. Nothing personal against Glenn Beck, but – if you're perceptive – you can easily get my point from that statement.

RFID Technology: Unlimited Potential, Inescapable Torment

RFID technology has long been researched, as early as the 1950s – and began official implementation back in the 1980s. RFID programs were originally used to research GPS tracking and defense systems – and have now begun to be used as identification and weapon technology.

RFID is able to completely “control” an individual, based on a simple frequency that can influence the individual's mind beyond the point of self-control.

In the 1960s, a bull was used as a “mind-control test” experiment. The bull was programmed to a certain “frequency” after being implanted with an RFID chip. The bull was “told” to attack, then told to “calm down.” The experiment drew much attention by military intelligence, because it worked (3).

With a simple wireless frequency, a bull stopped in mid-stride, refusing to attack the red sheet that he once knew as a threat. The bull immediately changed his character with one simple frequency, and decided that red carpets weren't that bad after all.

Why was this research performed by the CIA? For bulls to not attack red carpets? No. This research was performed on bulls, in order to be perfected – for humans.

Human mind control, notably that of the MK-Ultra program, involved giving “unsuspecting individuals” large amounts of LSD. A great example of what happens to people who participate in this program include: Ted Kaczynski – the Unabomber.

The Unabomber was a participant in the MK-Ultra program.

Once a Harvard genius, now a criminal, the Unabomber confessed multiple times that it was not his fault that he performed these actions. Nobody believed him.

However, official government documents state that he received multiple doses of LSD during the MK-Ultra research. Why was this not included in the criminal case against him?

The answer is simple. Government patsies are meant to look “insane.” They aren't meant to ever be believed for telling the truth.

Innocence is sniffed out like a rabid dog finds rotten flesh. No good deed goes unpunished. This excludes no-one. Always remember who owns this world, and never forget who put us here.

If a government will kill Jesus for speaking the truth, if a government will exile Moses for asking to free slaves, if a government will fight a war over keeping slaves so that they do not have to work the fields themselves – imagine what they will do for a paycheck.

Culture has changed, humanity has not.

For us “decent people,” most of these ideas seem insane. Absurd. Can't happen. Right?

Why?

We see through our own filter. We have a filter installed on our eyes, which is our personality. A naive person can be trusted, 99% of the time. Naive people do not see what is heading towards them... because they never create the train that would head down someone else's track.

In my personal experience, after 20-some odd years of being naïve myself, I have learned to trust no-one.

I forgive, I forget. I hold no grudges, and I still cannot fathom how others do. I live in the present, I hope for the future. Some rail on the past.

Regardless, you must learn from the past – while not living inside of it. If we know that organizations are corrupt, we know that they are likely to commit the same crimes in the future. If reforms are not present in someone's life after past mistakes, neither will they be for corrupt organizations.

The NSA and the FBI spied on MLK Jr., as mentioned.

There is no communist threat. There is no terrorist threat. There is a real threat. There is the threat to our personal liberty.

There are two sides to a coin, and there are only two types of people. When I was a

salesman, I learned a phrase called “KISS.” It was short for “Keep It Simple, Stupid.” I reminded myself of it often during my sales pitches.

What does it mean? How does it apply in life?

There are two poles to energy. Two sides to everything. As Morgan Freeman states: “there are two types of people... good people, and bad people.”

There is simply no other way to clarify what we face on a daily basis.

The Ultimate Goal of Government Surveillance: A Repeat of Ernest Hemingway's Life

For many years after the death of Ernest Hemingway, most of his friends and family thought that he had simply “went nuts” and shot himself.

Ernest Hemingway, believing federal agents were pursuing him, said “It’s the worst hell. The goddamnest hell. They’ve bugged everything. That’s why we’re using Duke’s car. Mine’s bugged. Everything’s bugged. Can’t use the phone. Mail intercepted. What put me on to it was that phone call with you. You remember we got disconnected? That tipped their hand.”

In 1999 Hotchner reported that through the Freedom of Information Act, he had discovered that the FBI and J. Edgar Hoover had, in fact, bugged Ernest Hemingway’s telephone.

The single most important part of this entire book, the entire point of the story, is that so many people are labeled “delusional” for thinking that the CIA or the FBI is “out to get them.”

Actually, this statement is labeled as a symptom of schizophrenia or psychosis in the DSM. However, I must state again, what do these organizations do for a living? They spy on people.

Some who claim stalking instances are delusional, obviously. Usually, its the same people who see pink fairies or purple zebras in their backyard. I'm not talking about those people.

I'm talking about the number one crime in America, considering all crimes committed: stalking. Stalking is, however, the crime that is ignored and unjustified more than any other crime – yet is more frustrating for the victim than could ever be imagined.

There is one of the three attached to each individual who claims to be a TI. It is up to police and investigators to find out which. All claims of stalking should be investigated thoroughly, as it is an extremely difficult matter for the truly targeted to deal with.

I will offer a recommendation for targeted individuals. I recommend that you contact police when you notice multiple instances of the same thing. Do not give police details of what is going on. Remember what I mentioned in the previous chapter? Leave the investigating to the investigators. (KISS, Keep It Simple, Stupid.)

Report facts (only) to the police. Let the police do their job and investigate the rest of the case for you. Never assume anything, always do something different and out of sorts.

Routines and schedules, for a stalker, are like a daily agenda for them to plan out for your life.

If you go to work at 9am, the agenda for your stalker could include your home being broken into by 10am. If you call into work that day, you just ruined the stalkers plan. In cases of “gang stalking” or organized stalking, communication is required. Meet-ups are usual, telecommunications are rare, texts are frequent.

As the FBI loves to involve the community in their harassment campaign against citizens, which accomplishes multiple goals at the same time (trains the public to hate and distrust while recruiting free workers), you can always remember that police and the NSA have some people under strict surveillance – and it has nothing to do with your instance of stalking.

Let them get a cokehead to stalk you. Let the cokehead run around your block 20 times, until he runs out of cocaine. What will he do? Text someone for more cocaine. The police are already watching him – because crackheads are just pretty obvious to police and the neighborhood in general.

So, when a cokehead becomes an “informant” - which is already under legitimate surveillance by police – guess what else that the police find out?

That you are being stalked and harassed by the cokehead/crackhead. This draws attention, clarifies the situation, and relieves you of all accusations of “paranoia” and/or delusion.

Be thankful when they hire a crackhead as an “informant.” It's your leprechaun that points to the pot of gold under your rainbow.

I question the fact that people who are truly under surveillance are ever labeled as “delusional or paranoid.”

Official government documents prove that Ernest Hemingway, a classic American author, was under surveillance for nearly 20 years – without cause. It ultimately led to his death, and J. Edgar Hoover and the FBI is responsible for his torture and murder.

Jean Seberg, God rest her soul, was a beautiful, talented, and successful actress. One day, President Hoover and the FBI decided to take interest in her.

What did Jean Seberg do? Did she commit a crime?

Jean Seberg contributed to the Black Panther party during the civil rights movement. She gave approximately \$10,500 in cash and gifts to the organization.

This is one example of many, and the ultimate goal of organized stalking and surveillance. While the criminals roam free, people who work for a living are stalked, harassed, and tortured – for no reason.

These people, presently numbering in the thousands, report the same detailed explanations of something that they are not able to stop. Former CIA officials and “Voice of God” weapons creators verify the existence of these programs.
